



The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Moser GmbH Co KG is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 860% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 109% points below the market average of 202%.
