



The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 443% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Bs Ass Currass Inventory Inprogress Rem, reducing the Economic Capital Ratio by 483% points.

The company's Economic Capital Ratio, given in the ranking table, is 567%, being 365% points above the market average of 202%.
