



The relative strengths and weaknesses of ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 98% points. The greatest weakness of ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft is the variable Operating Result Tc, reducing the Economic Capital Ratio by 481% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 104% points below the market average of 202%.
