



The relative strengths and weaknesses of SVI Vertriebs und Immobilien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SVI Vertriebs und Immobilien GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 154% points. The greatest weakness of SVI Vertriebs und Immobilien GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 415% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 46% points below the market average of 202%.
