



The relative strengths and weaknesses of Ruben Schäfer Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 250% points.

The company's Economic Capital Ratio, given in the ranking table, is 64%, being 43% points below the market average of 107%.
