



The relative strengths and weaknesses of Gunter Hüttner Co GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gunter Hüttner Co GmbH Bauunternehmung compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Gunter Hüttner Co GmbH Bauunternehmung is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 158% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 34% points below the market average of 107%.
