



The relative strengths and weaknesses of Mark A Krüger Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mark A Krüger Bauunternehmung GmbH compared to the market average is the variable Gross Revenue For The Period Tc, increasing the Economic Capital Ratio by 151% points. The greatest weakness of Mark A Krüger Bauunternehmung GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 920% points.

The company's Economic Capital Ratio, given in the ranking table, is 151%, being 44% points above the market average of 107%.
