



The relative strengths and weaknesses of Bauunternehmung Ezel Torgau GmbH Torgau Elbe are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Ezel Torgau GmbH Torgau Elbe compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 180% points. The greatest weakness of Bauunternehmung Ezel Torgau GmbH Torgau Elbe is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 919% points.

The company's Economic Capital Ratio, given in the ranking table, is 180%, being 73% points above the market average of 107%.
