



The relative strengths and weaknesses of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 109% points. The greatest weakness of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 383% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 2,0% points above the market average of 107%.
