The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Rem, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 121% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 6,4% points below the market average of 107%.
