



The relative strengths and weaknesses of i RB Industrie Gewerbebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of i RB Industrie Gewerbebau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 62% points. The greatest weakness of i RB Industrie Gewerbebau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 333% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 33% points below the market average of 94%.
