



The relative strengths and weaknesses of W Markgraf GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of W Markgraf GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 109% points. The greatest weakness of W Markgraf GmbH Co KG Bauunternehmung is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 1.126% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 7,6% points above the market average of 101%.
