



The relative strengths and weaknesses of Arning Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Arning Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Rem, reducing the Economic Capital Ratio by 1.049% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 26% points below the market average of 101%.
