

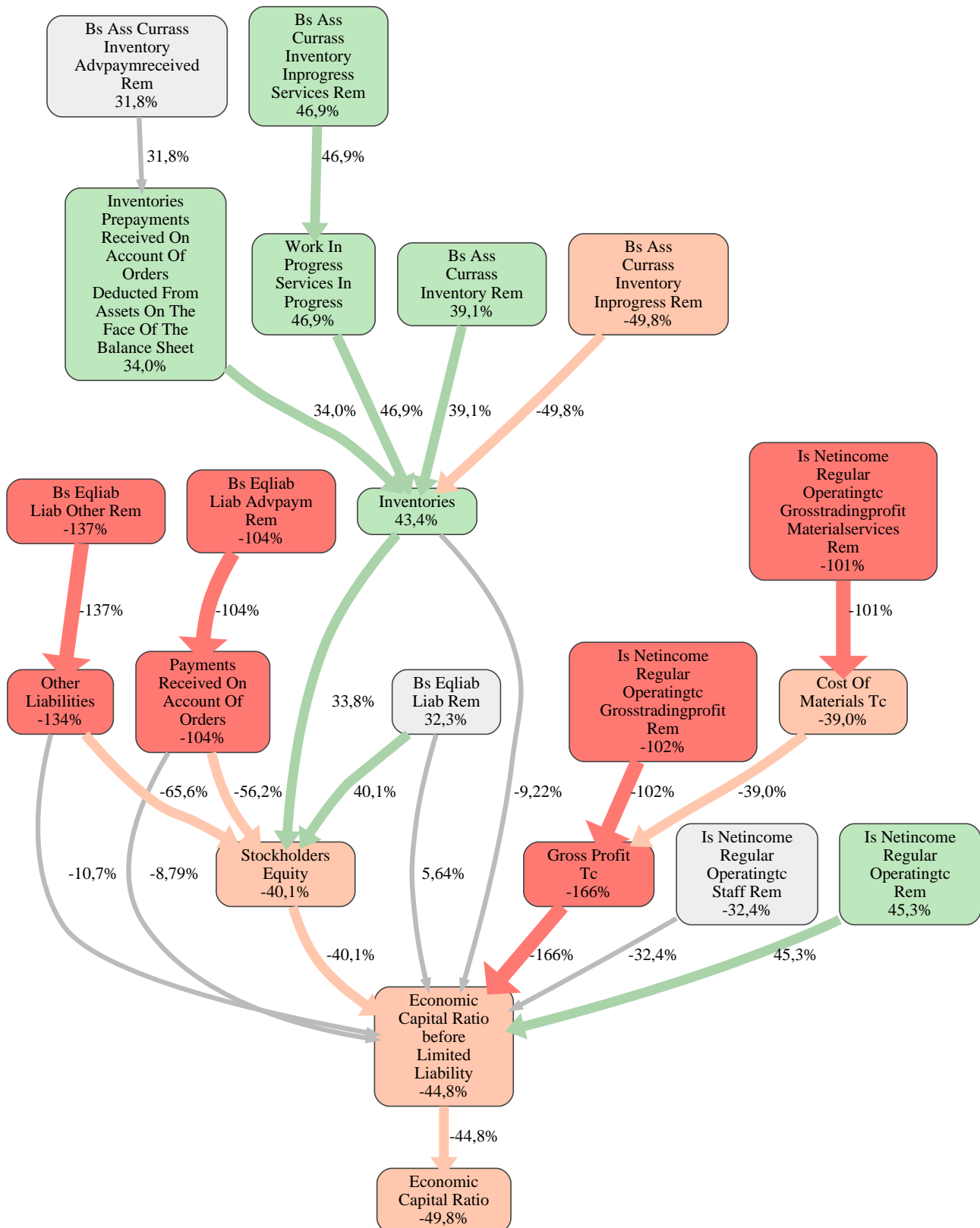

The relative strengths and weaknesses of Lim Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Services Rem, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 166% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 50% points below the market average of 101%.
