



The relative strengths and weaknesses of Bonava Wohnbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bonava Wohnbau GmbH compared to the market average is the variable Bs Ass Currass Inventory Rem, increasing the Economic Capital Ratio by 32% points. The greatest weakness of Bonava Wohnbau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 294% points.

The company's Economic Capital Ratio, given in the ranking table, is 32%, being 69% points below the market average of 101%.
