



The relative strengths and weaknesses of Bauunternehmung Albert Weil Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 111% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 847% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 12% points above the market average of 99%.
