

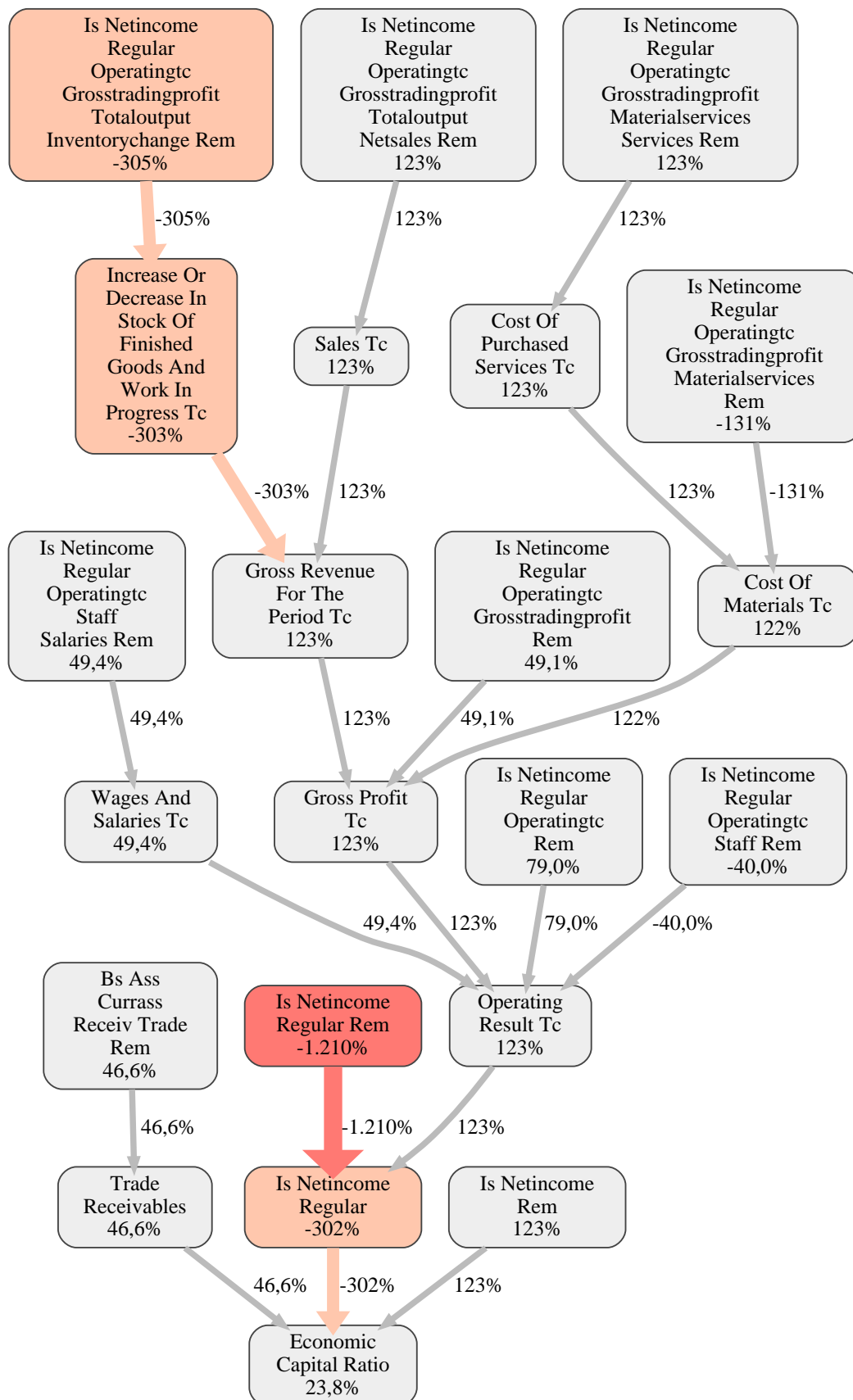

The relative strengths and weaknesses of Hetzel Sponheuer GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hetzel Sponheuer GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 123% points. The greatest weakness of Hetzel Sponheuer GmbH Co KG is the variable Is Netincome Regular Rem, reducing the Economic Capital Ratio by 1.210% points.

The company's Economic Capital Ratio, given in the ranking table, is 123%, being 24% points above the market average of 99%.
