The greatest strength of Wunstorfer Bauverein Wohnungsbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Salaries Rem, increasing the Economic Capital Ratio by 0,00012% points. The greatest weakness of Wunstorfer Bauverein Wohnungsbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 393% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,00012%, being 99% points below the market average of 99%.
