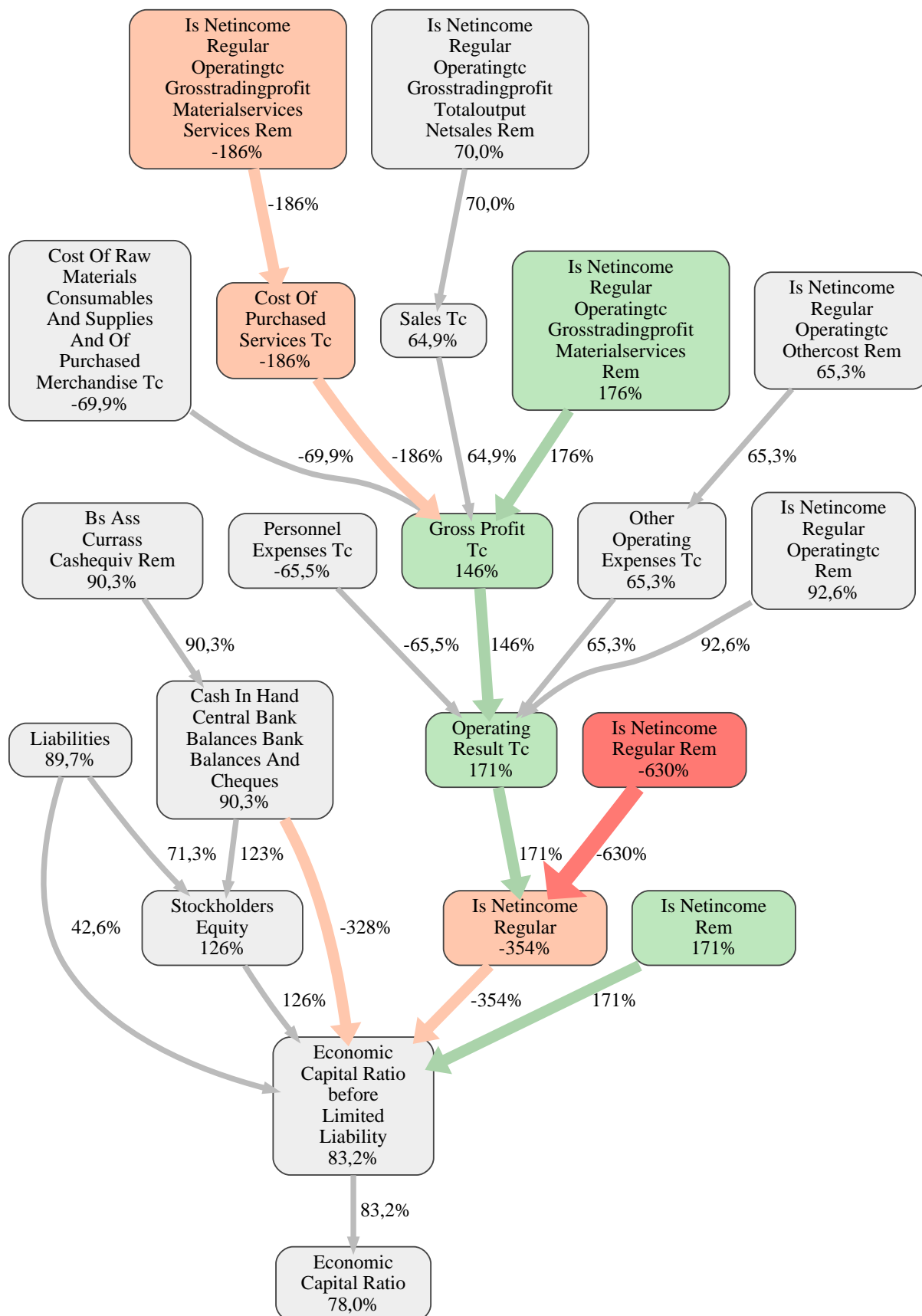

The relative strengths and weaknesses of Westdeutsche Rohbau Technik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Westdeutsche Rohbau Technik GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 176% points. The greatest weakness of Westdeutsche Rohbau Technik GmbH is the variable Is Netincome Regular Rem, reducing the Economic Capital Ratio by 630% points.

The company's Economic Capital Ratio, given in the ranking table, is 177%, being 78% points above the market average of 99%.
