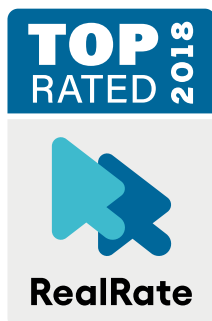

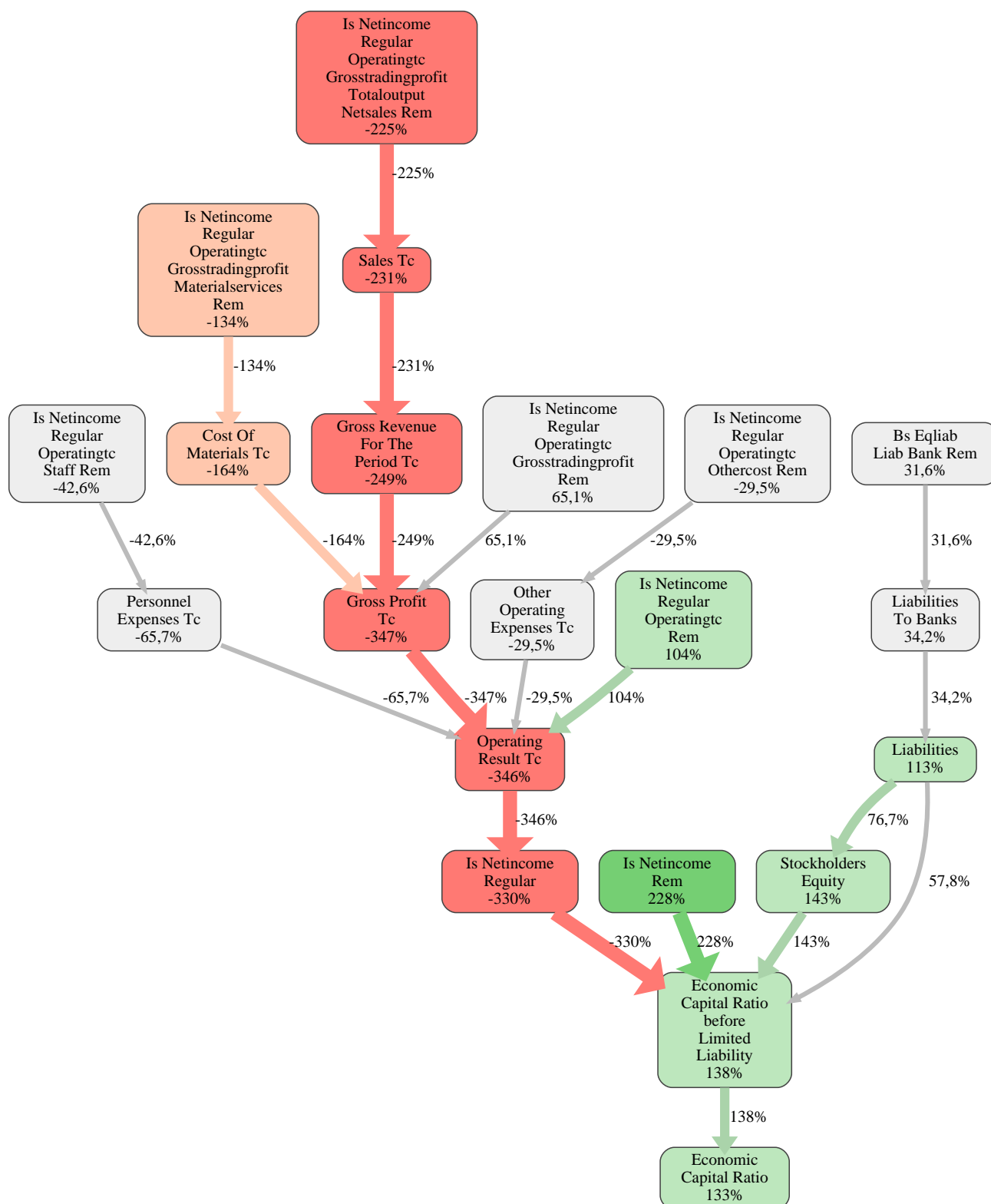

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 228% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 347% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 133% points above the market average of 99%.
