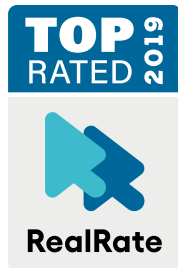

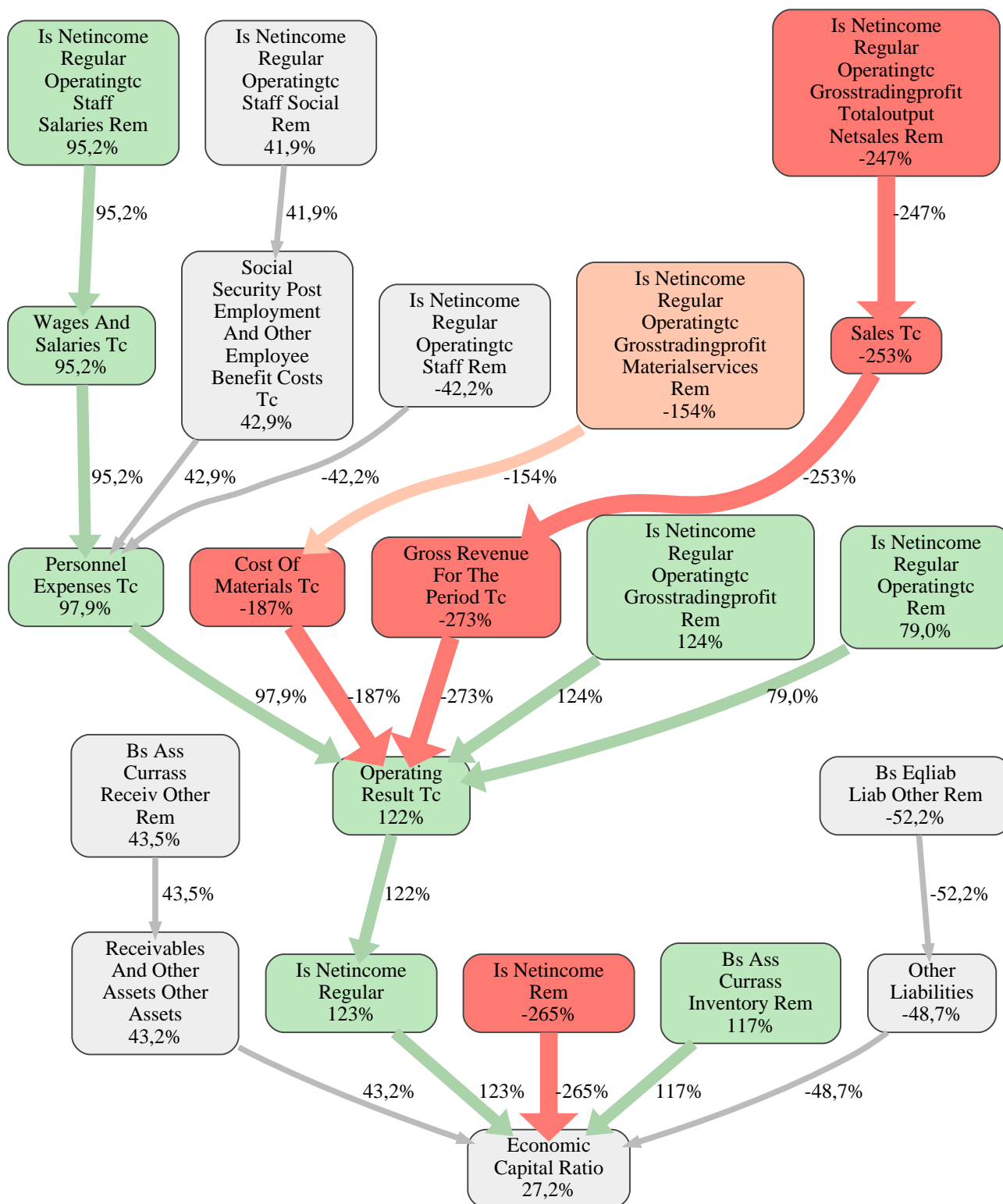

The relative strengths and weaknesses of Bauunternehmung Glöckle Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle Hoch und Tiefbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 124% points. The greatest weakness of Bauunternehmung Glöckle Hoch und Tiefbau GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 273% points.

The company's Economic Capital Ratio, given in the ranking table, is 124%, being 27% points above the market average of 97%.
