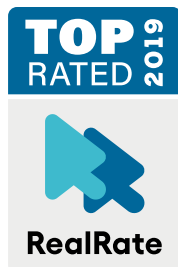

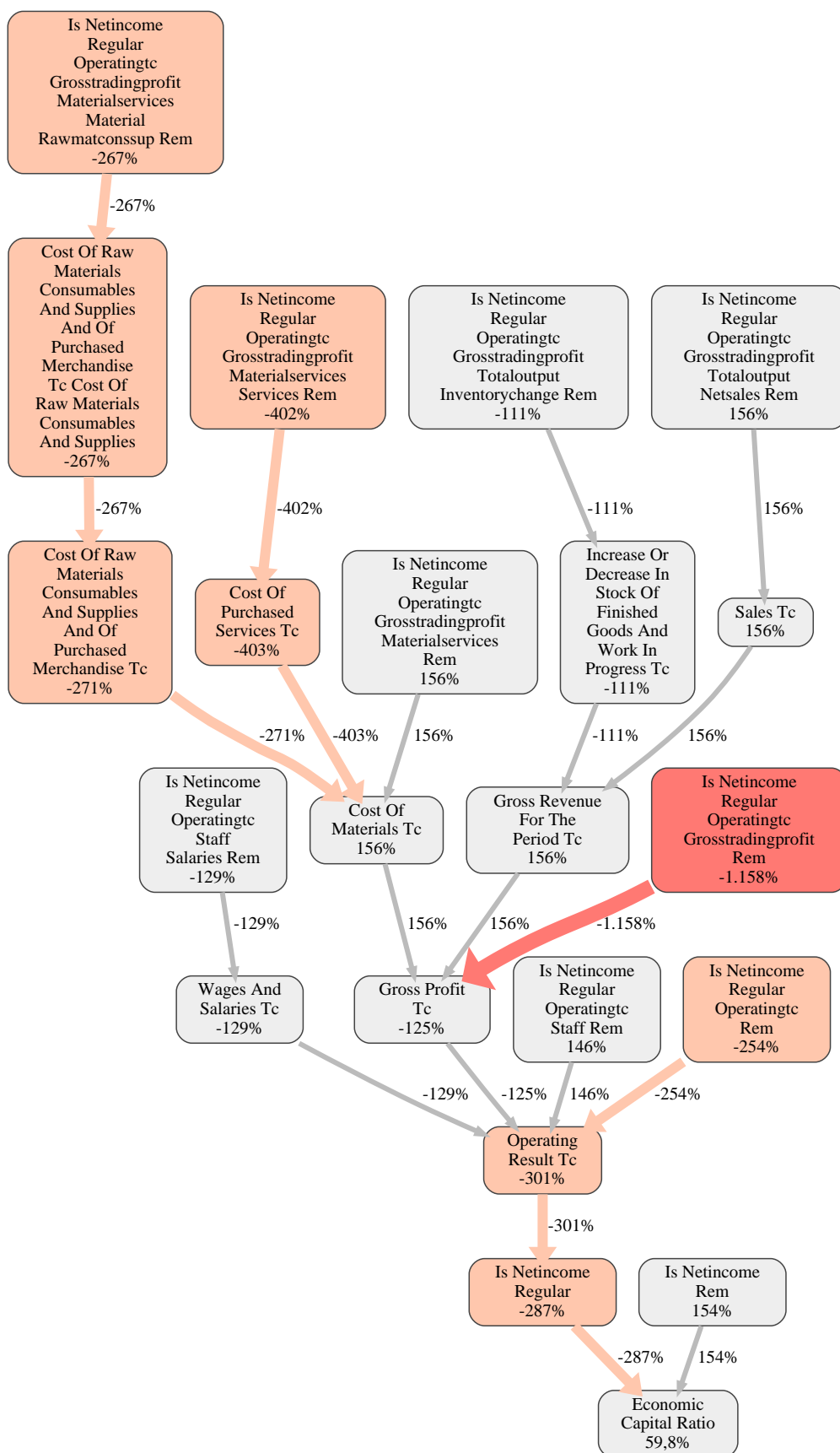

The greatest strength of Hans Holzner Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 156% points. The greatest weakness of Hans Holzner Baugesellschaft mbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 1.158% points.

The company's Economic Capital Ratio, given in the ranking table, is 156%, being 60% points above the market average of 97%.
