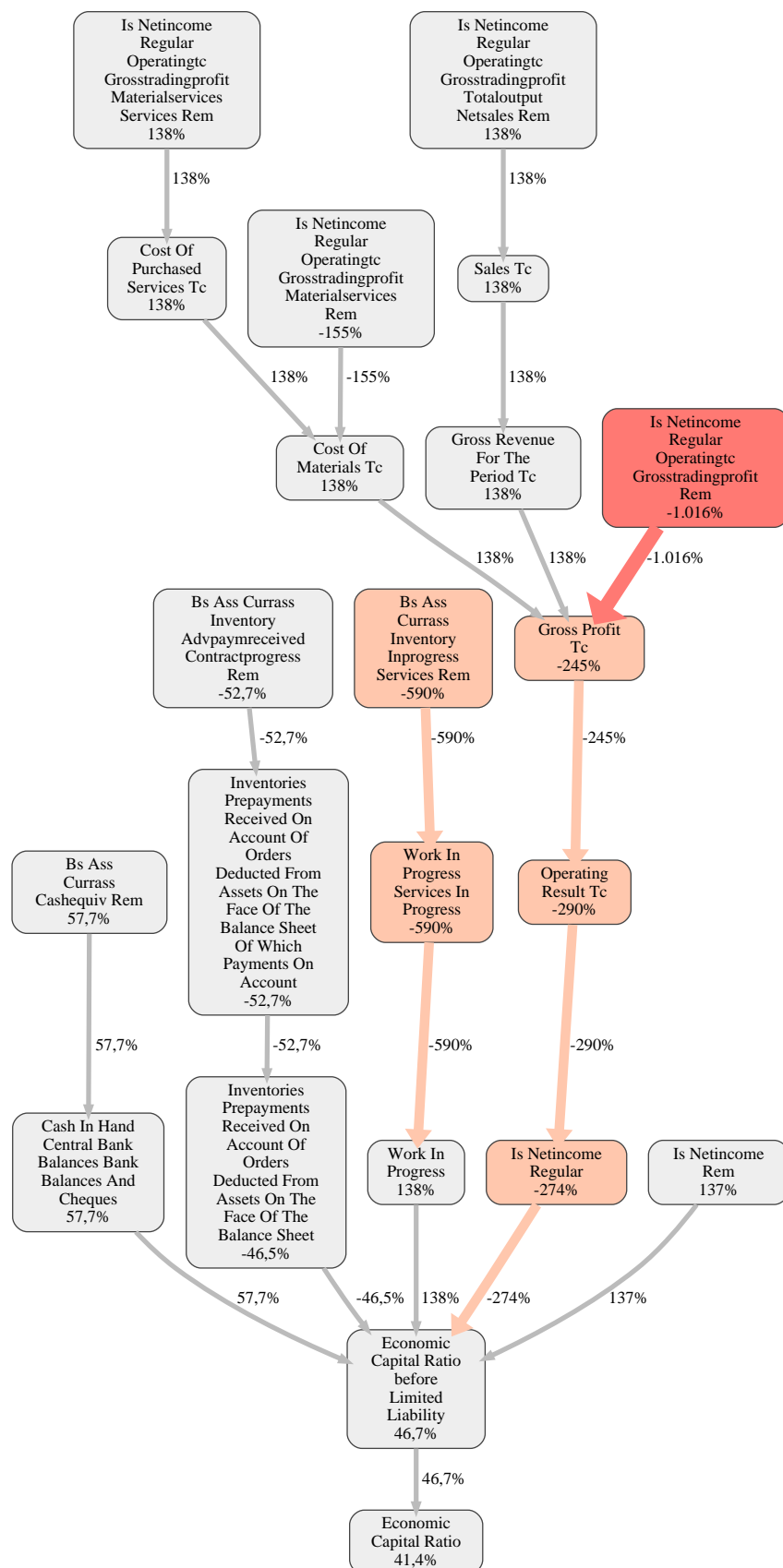

The relative strengths and weaknesses of SF BAU Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SF BAU Moser GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 138% points. The greatest weakness of SF BAU Moser GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 1.016% points.

The company's Economic Capital Ratio, given in the ranking table, is 138%, being 41% points above the market average of 97%.
