



The relative strengths and weaknesses of Derichs u Konertz GmbH u Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Derichs u Konertz GmbH u Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Derichs u Konertz GmbH u Co KG is the variable Bs Ass Currass Inventory Inprogress Rem, reducing the Economic Capital Ratio by 1.034% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 20% points below the market average of 103%.
