



The relative strengths and weaknesses of Kögel Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kögel Bau GmbH Co KG compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Kögel Bau GmbH Co KG is the variable Bs Ass Currass Inventory Inprogress Rem, reducing the Economic Capital Ratio by 1.126% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 26% points below the market average of 103%.
