



The relative strengths and weaknesses of Ruben Schäfer Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 902% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 9,7% points below the market average of 103%.
