



The relative strengths and weaknesses of Baugesellschaft Walter Hellmich GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Baugesellschaft Walter Hellmich GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, increasing the Economic Capital Ratio by 112% points. The greatest weakness of Baugesellschaft Walter Hellmich GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 319% points.

The company's Economic Capital Ratio, given in the ranking table, is 112%, being 9,0% points above the market average of 103%.
