



The relative strengths and weaknesses of Peter Ahrens Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 2.676% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 13% points below the market average of 103%.
