



The relative strengths and weaknesses of Mayerhofer Hoch Tief und Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mayerhofer Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Mayerhofer Hoch Tief und Ingenieurbau GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 376% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 12% points below the market average of 103%.
