

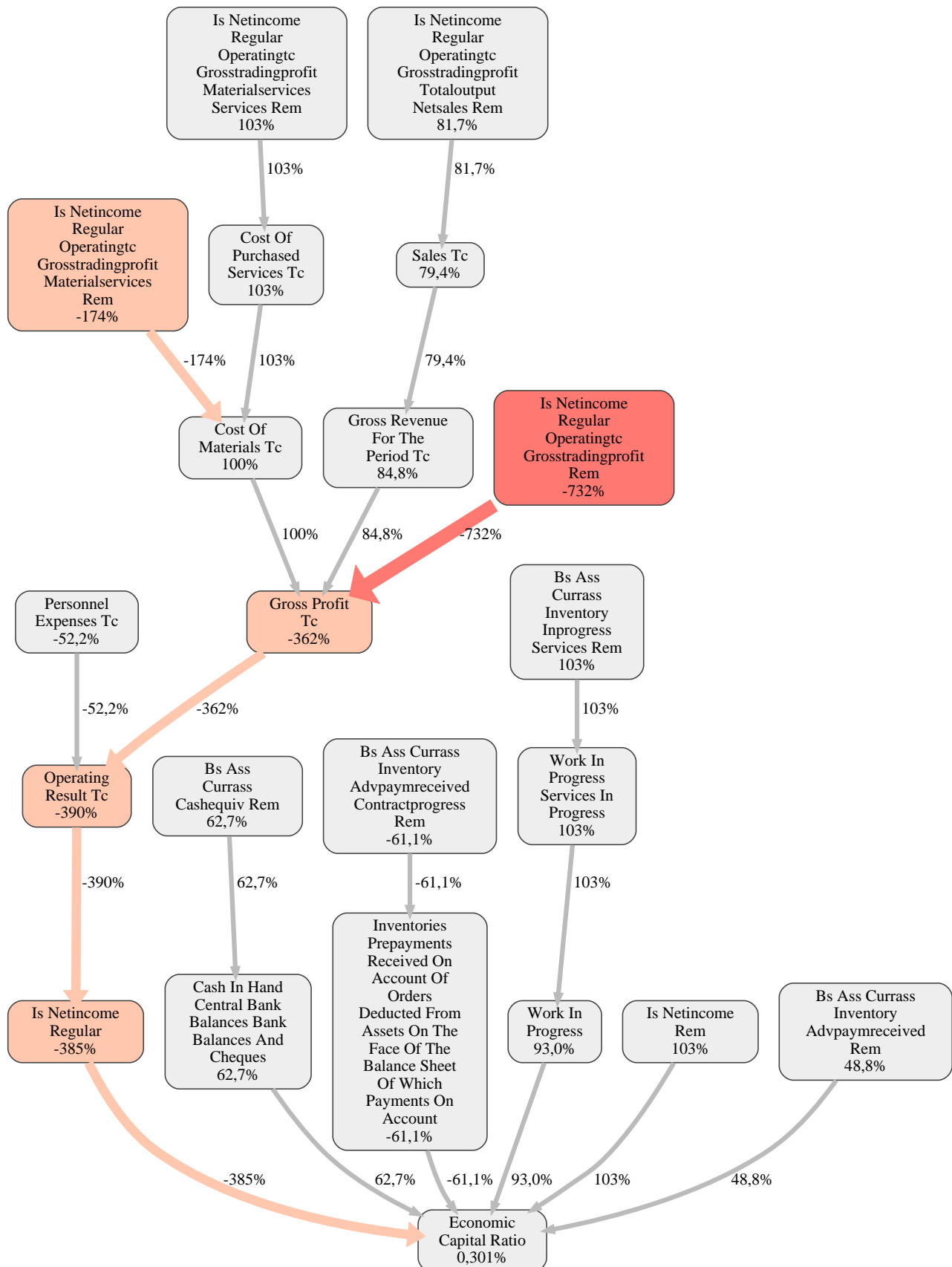

The greatest strength of SF BAU Moser GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 103% points. The greatest weakness of SF BAU Moser GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 732% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 0,30% points above the market average of 103%.
