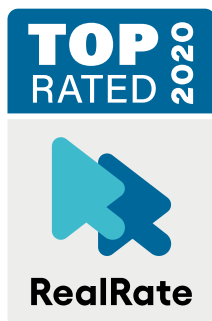

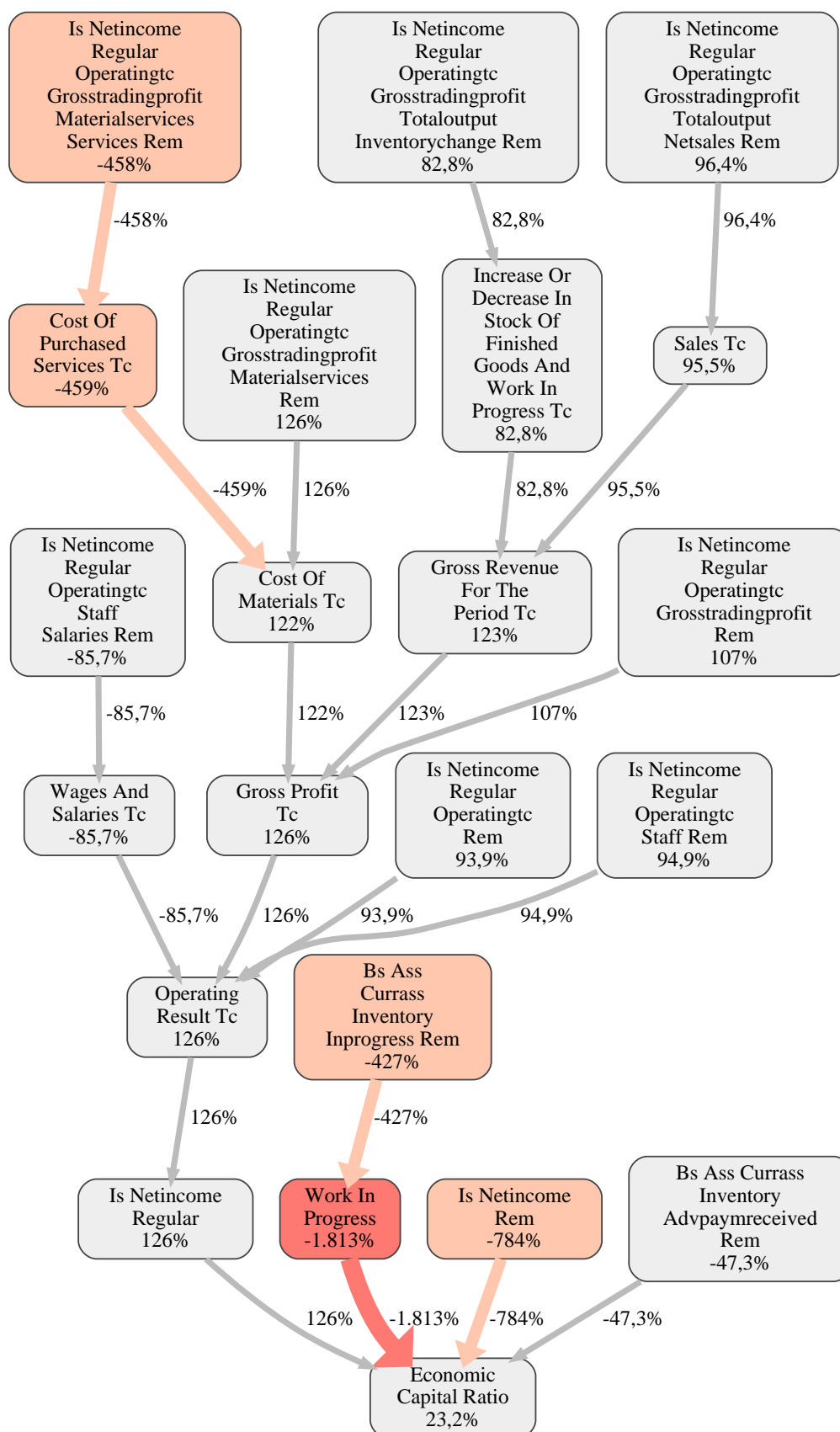

The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 126% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 1.813% points.

The company's Economic Capital Ratio, given in the ranking table, is 126%, being 23% points above the market average of 103%.
