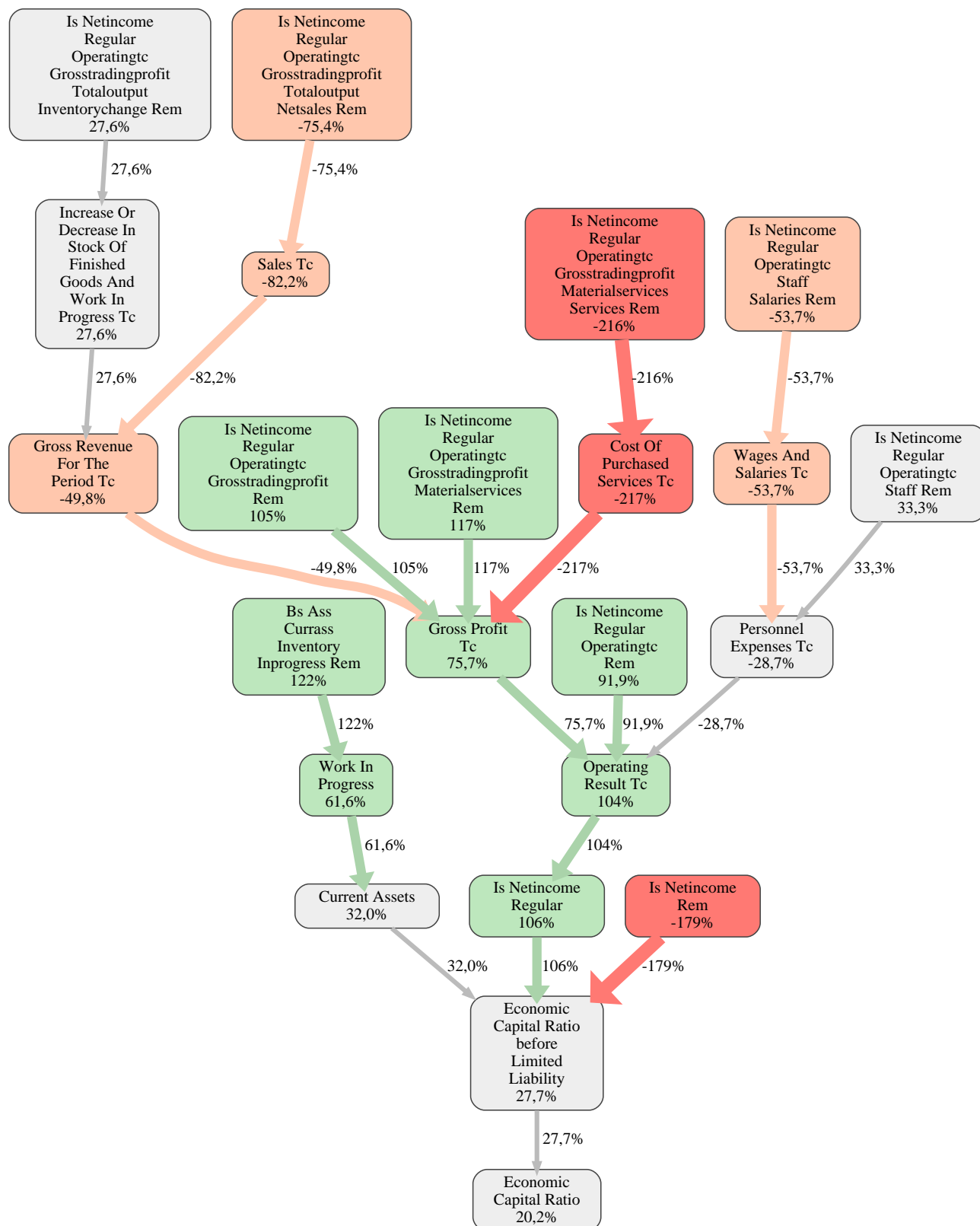

The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Rem, increasing the Economic Capital Ratio by 122% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 217% points.

The company's Economic Capital Ratio, given in the ranking table, is 123%, being 20% points above the market average of 103%.
