

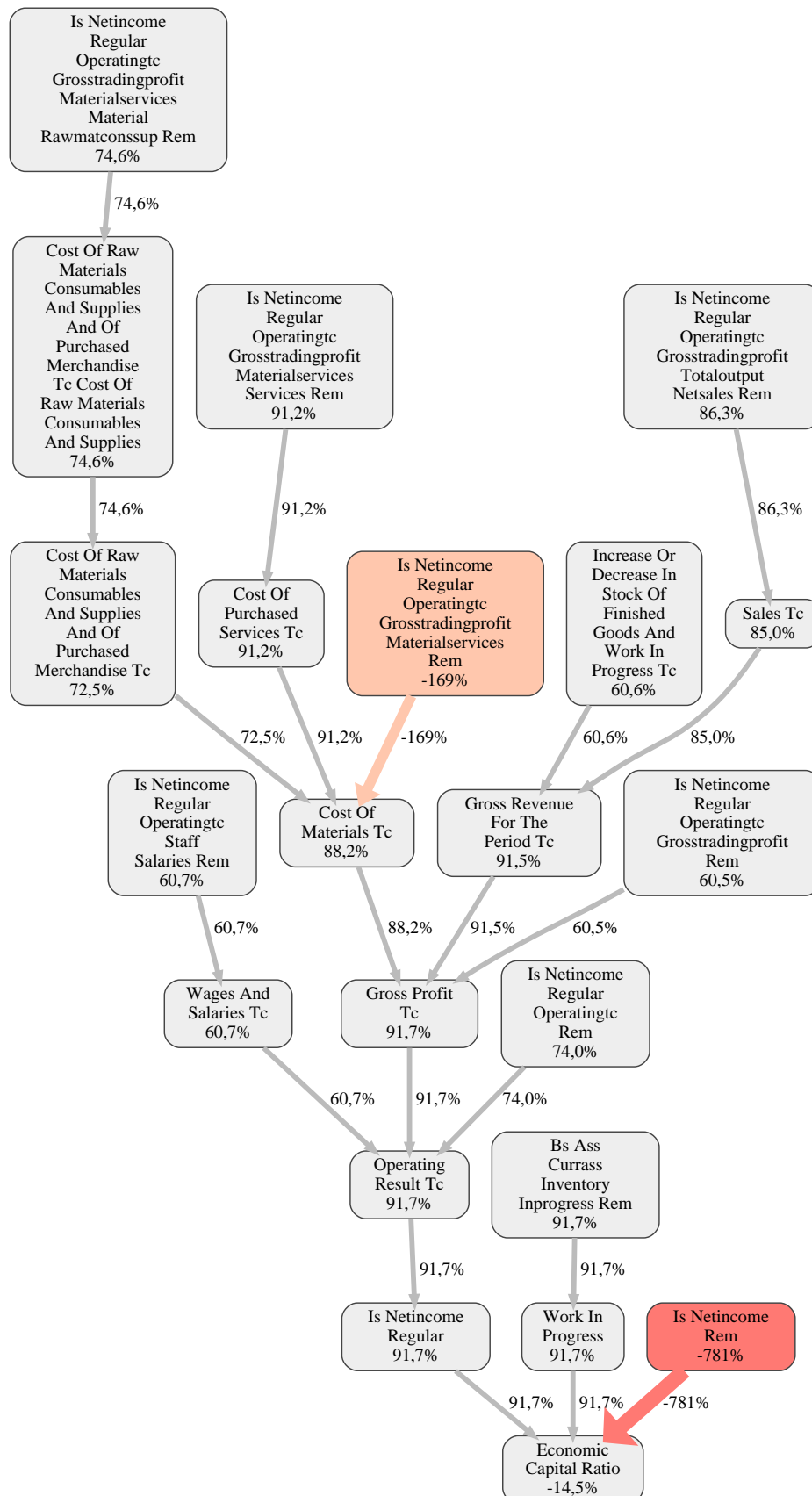

The relative strengths and weaknesses of Florack Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Florack Bauunternehmung GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Rem, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Florack Bauunternehmung GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 781% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 15% points below the market average of 106%.
