

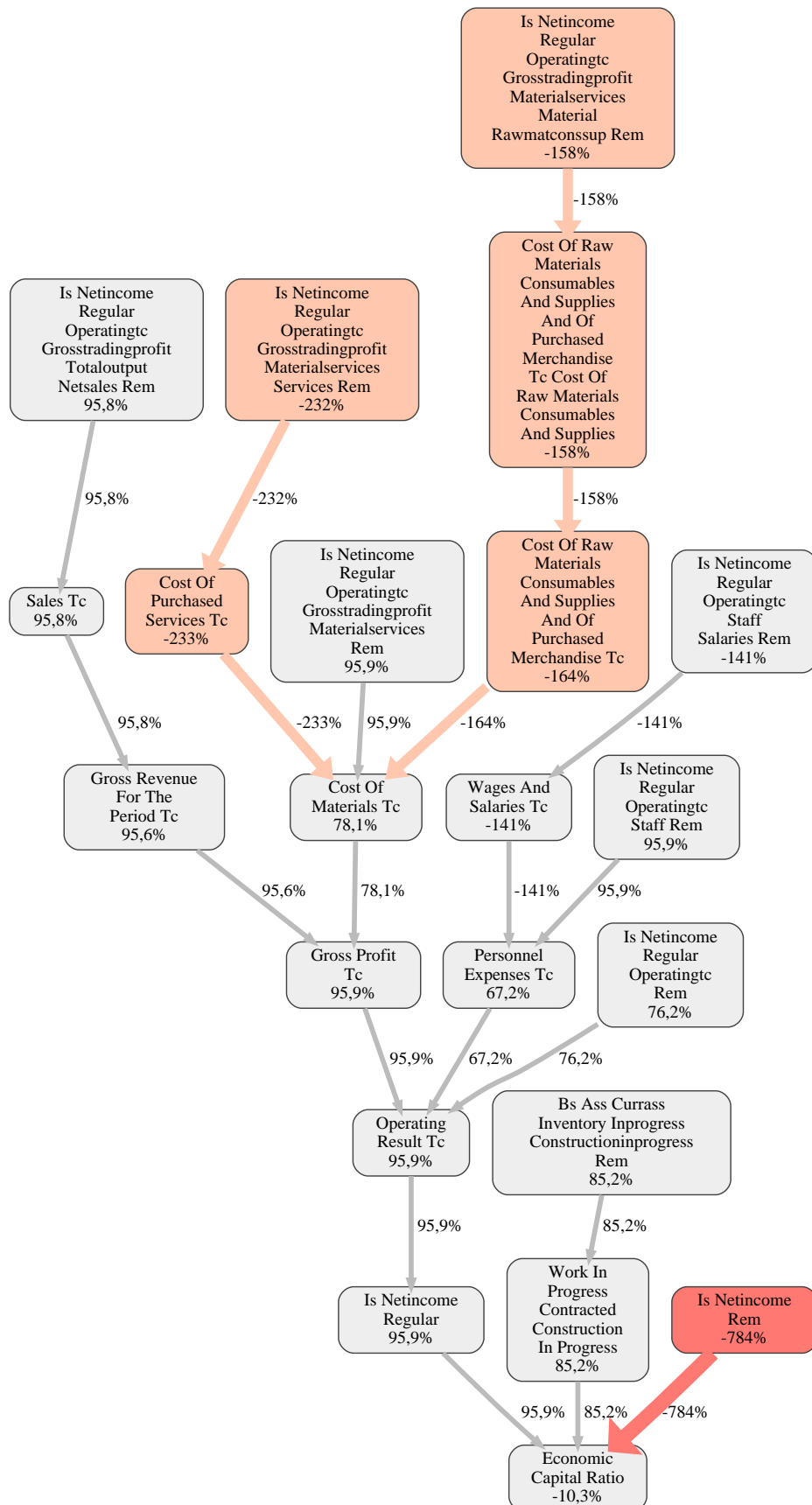

The relative strengths and weaknesses of Tell Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tell Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Tell Bau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 784% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 10% points below the market average of 106%.
