The greatest strength of Mark A Krüger Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Mark A Krüger Bauunternehmung GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 163% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 28% points below the market average of 106%.
