

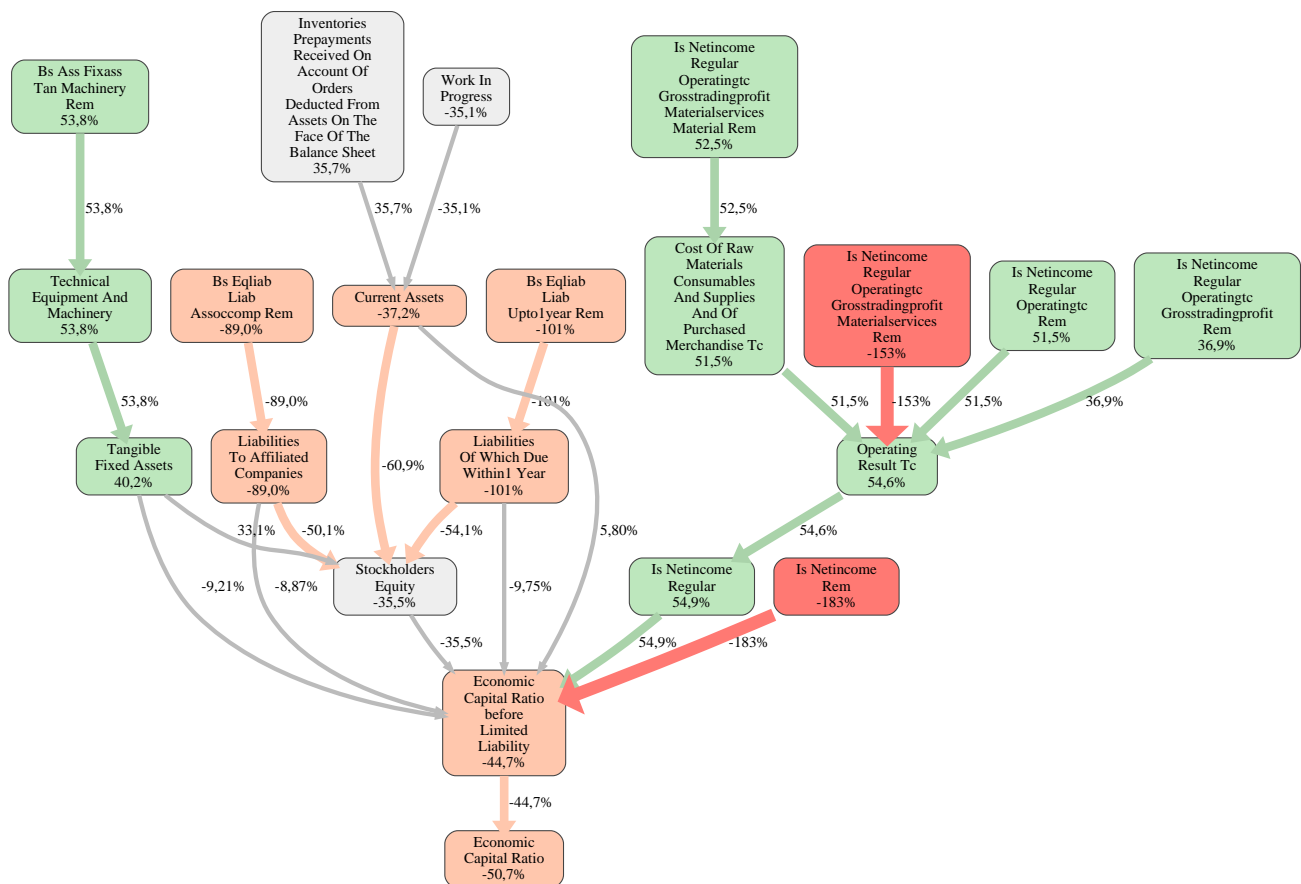

The relative strengths and weaknesses of Hanova Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Services GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 55% points. The greatest weakness of Hanova Services GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 183% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 51% points below the market average of 106%.
