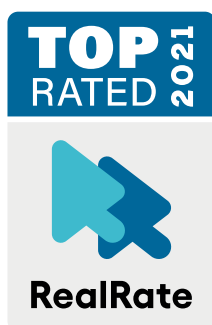

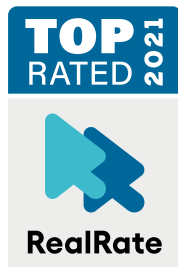

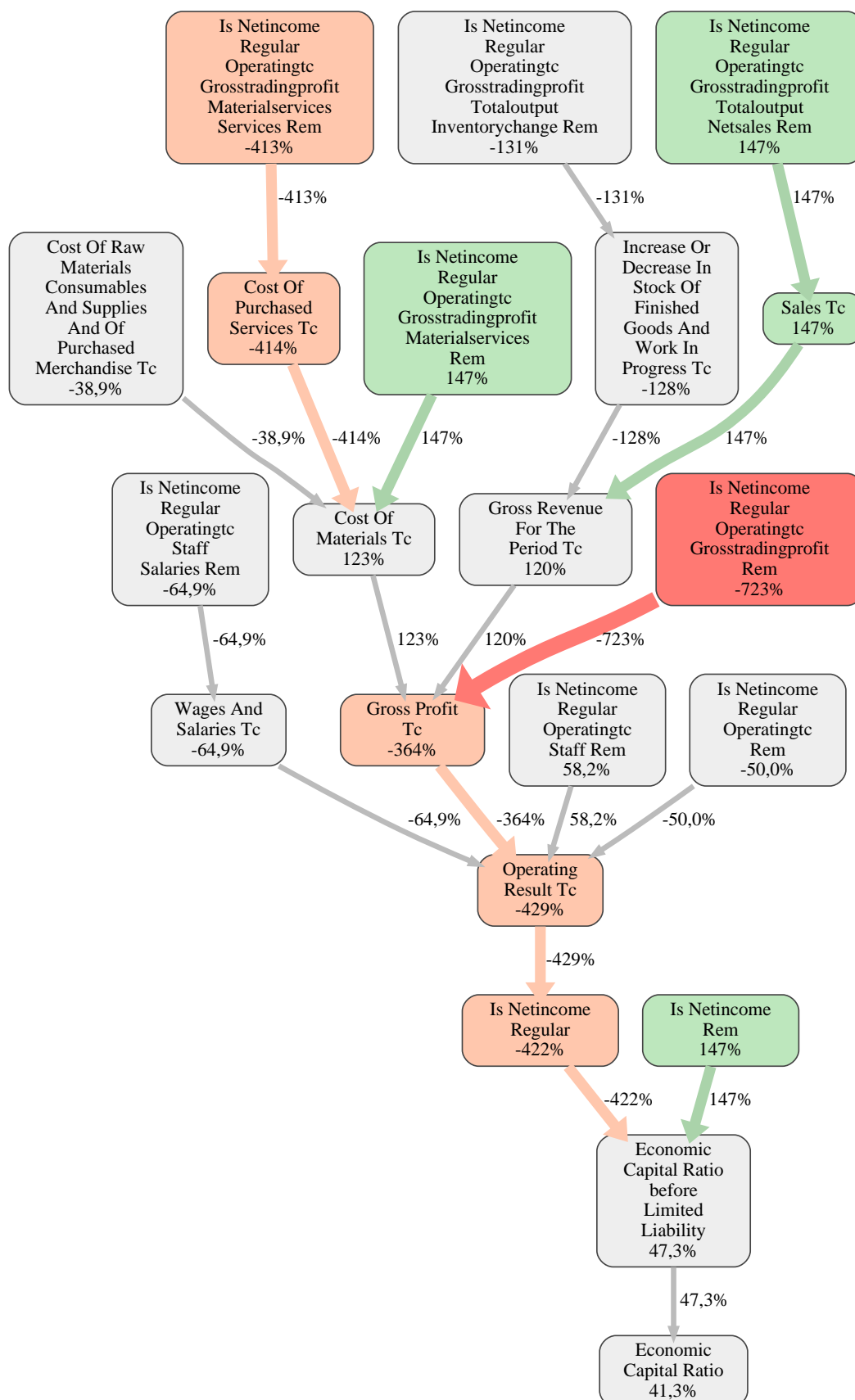

The greatest strength of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 147% points. The greatest weakness of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 723% points.

The company's Economic Capital Ratio, given in the ranking table, is 147%, being 41% points above the market average of 106%.
