



The relative strengths and weaknesses of MSB Bauausführungen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MSB Bauausführungen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 170% points. The greatest weakness of MSB Bauausführungen GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 3.817% points.

The company's Economic Capital Ratio, given in the ranking table, is 170%, being 67% points above the market average of 103%.
