



The relative strengths and weaknesses of BAM Corporate Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BAM Corporate Services GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 3,3% points. The greatest weakness of BAM Corporate Services GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 389% points.

The company's Economic Capital Ratio, given in the ranking table, is 3,3%, being 100% points below the market average of 103%.
