

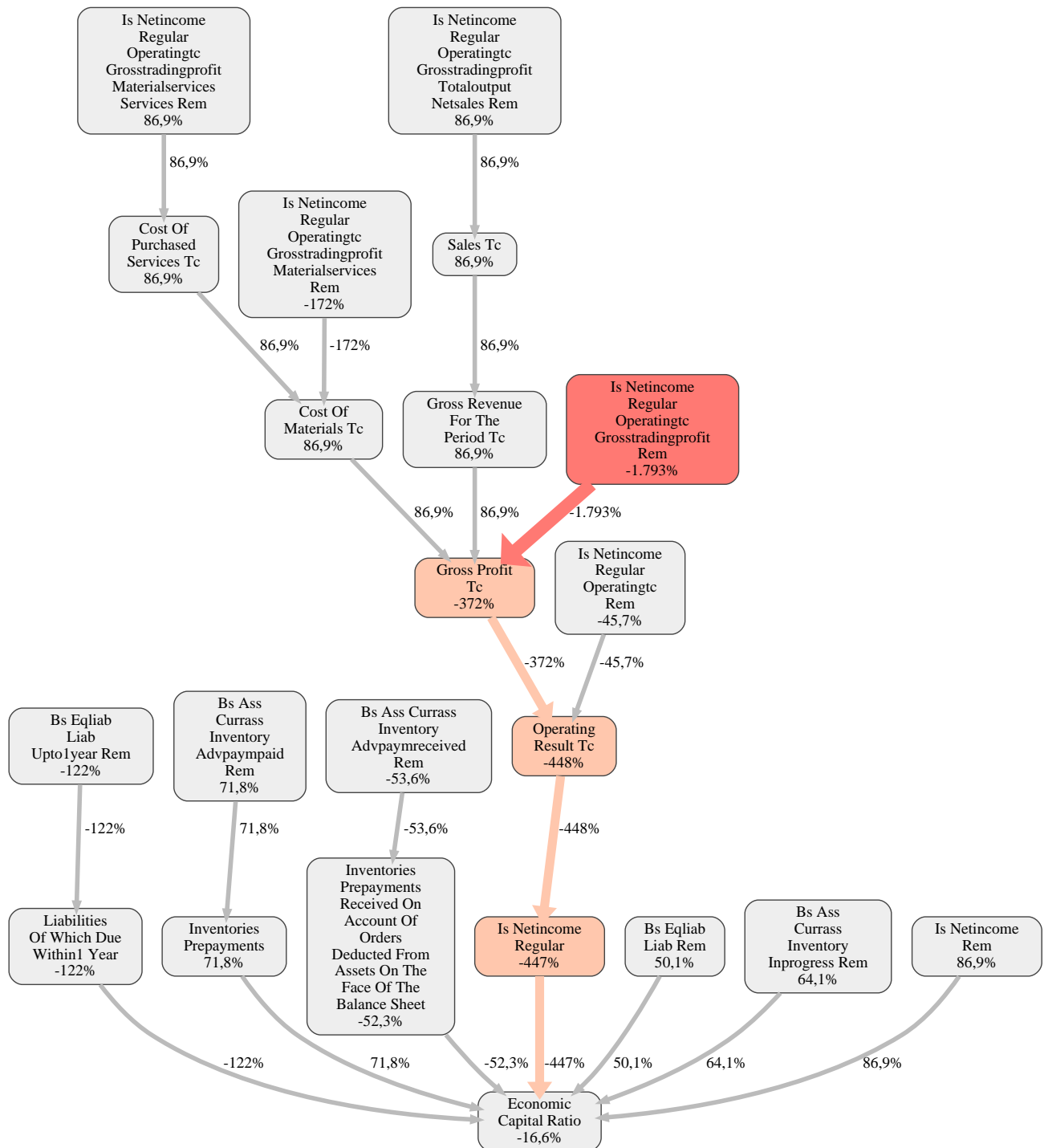

The relative strengths and weaknesses of i RB Industrie Gewerbebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of i RB Industrie Gewerbebau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 87% points. The greatest weakness of i RB Industrie Gewerbebau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 1.793% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 17% points below the market average of 103%.
