

The greatest strength of Faber Schnepf Hoch und Tiefbau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Faber Schnepf Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 162% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 37% points below the market average of 103%.
