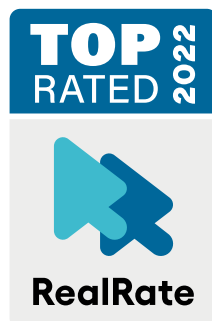

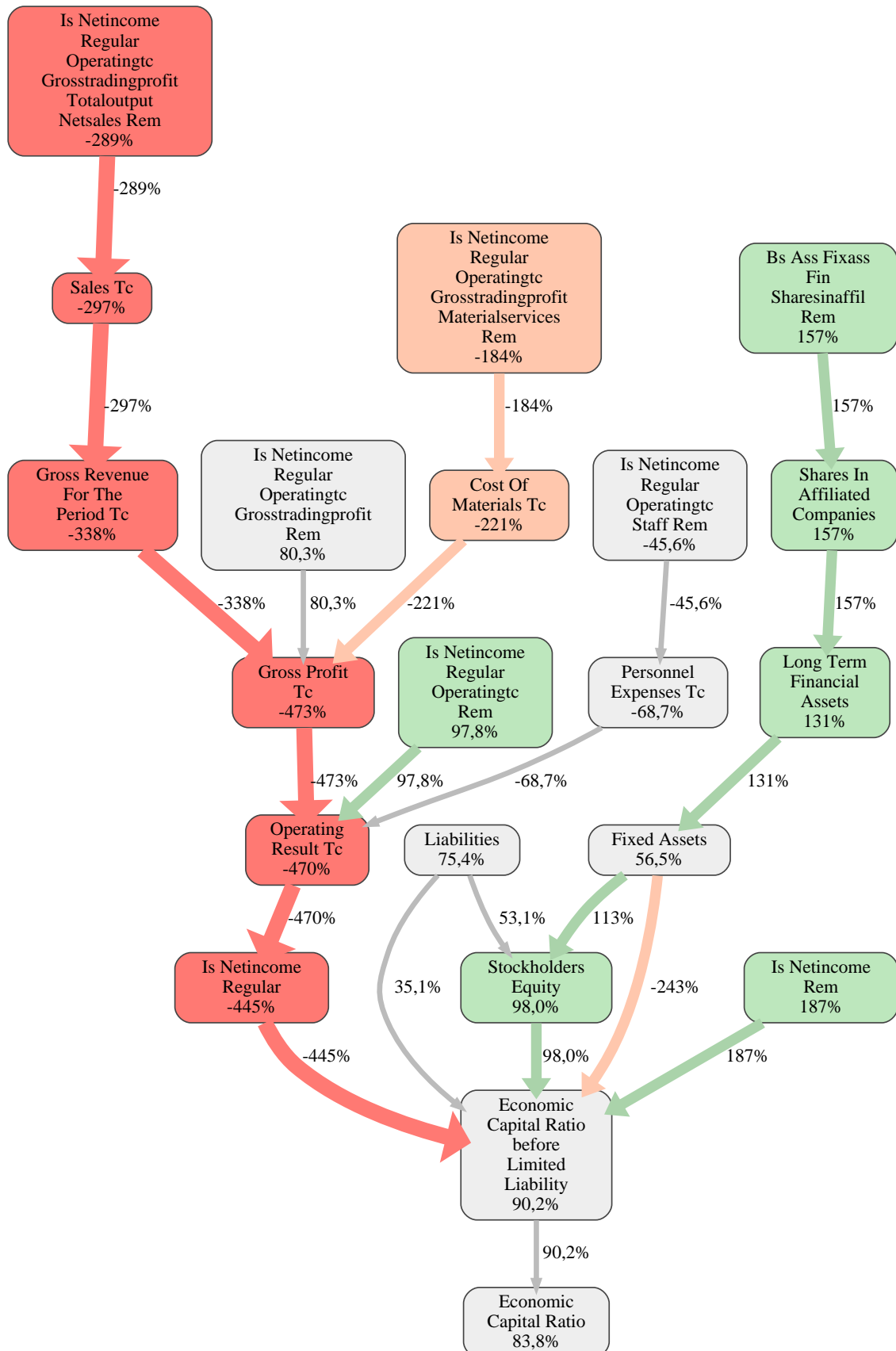

The relative strengths and weaknesses of GWH Immobilien Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GWH Immobilien Holding GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 187% points. The greatest weakness of GWH Immobilien Holding GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 473% points.

The company's Economic Capital Ratio, given in the ranking table, is 187%, being 84% points above the market average of 103%.
