



The relative strengths and weaknesses of Ludwig Pfeiffer Hoch und Tiefbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ludwig Pfeiffer Hoch und Tiefbau GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 65% points. The greatest weakness of Ludwig Pfeiffer Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 544% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 137% points below the market average of 202%.
