



The relative strengths and weaknesses of Bauunternehmung Albert Weil Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 469% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 107% points below the market average of 202%.
