



The relative strengths and weaknesses of Bauunternehmung Glöckle Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle Hoch und Tiefbau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Bauunternehmung Glöckle Hoch und Tiefbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 866% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 97% points below the market average of 202%.
