



The relative strengths and weaknesses of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 110% points. The greatest weakness of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 478% points.

The company's Economic Capital Ratio, given in the ranking table, is 110%, being 92% points below the market average of 202%.
