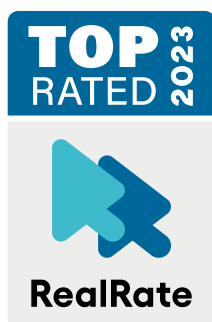

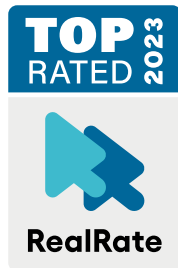

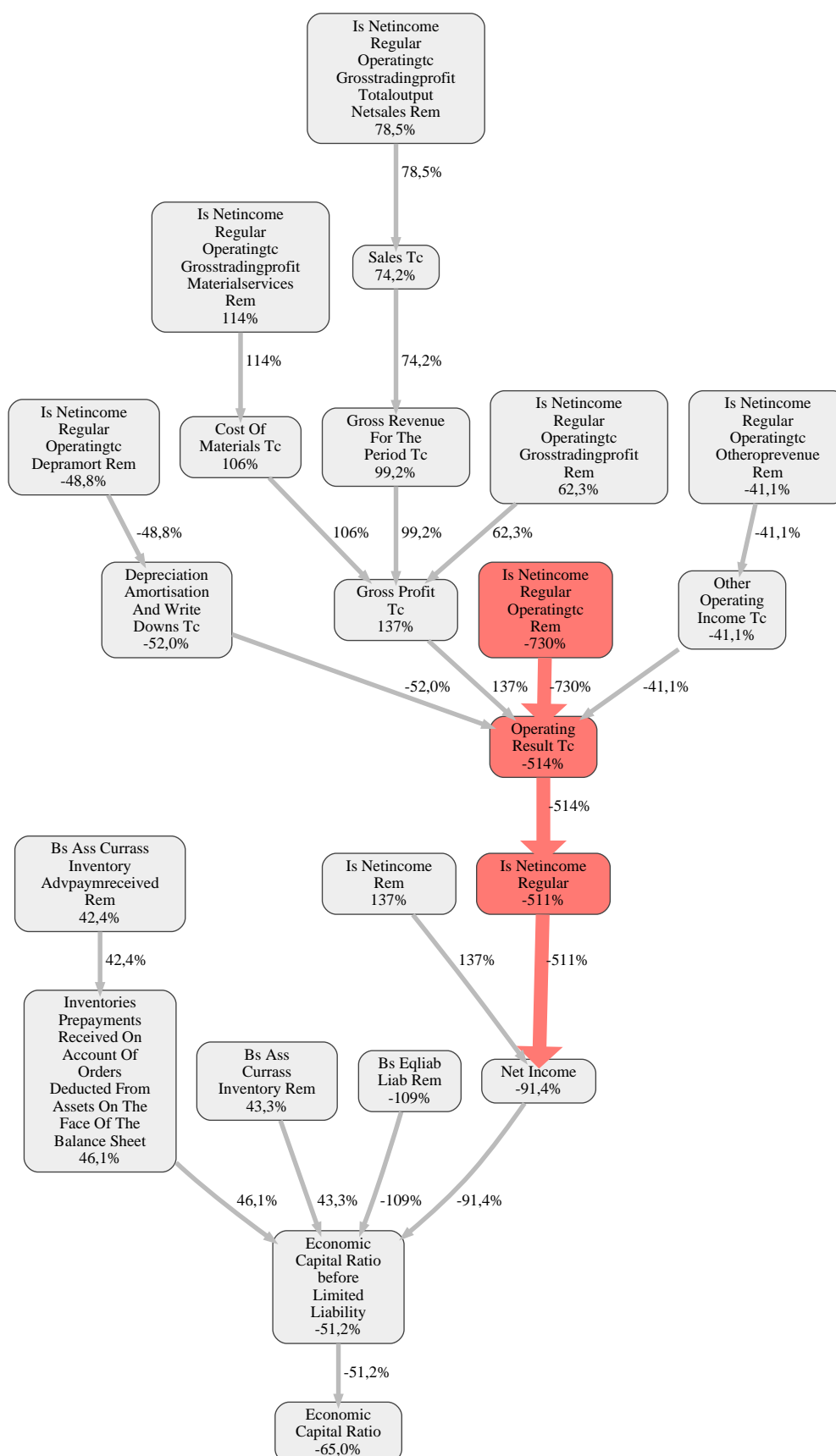

The relative strengths and weaknesses of Ortwin Goldbeck Holding SE Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE Konzern compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 137% points. The greatest weakness of Ortwin Goldbeck Holding SE Konzern is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 730% points.

The company's Economic Capital Ratio, given in the ranking table, is 137%, being 65% points below the market average of 202%.
