

#### Ulrich Reitenberger Bau GmbH Rank 4 of 108

The relative strengths and weaknesses of Ulrich Reitenberger Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ulrich Reitenberger Bau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 227% points. The greatest weakness of Ulrich Reitenberger Bau GmbH is the variable Buildings On Third Party Land, reducing the Economic Capital Ratio by 237% points.

The company's Economic Capital Ratio, given in the ranking table, is 480%, being 225% points above the market average of 255%.
