

Bien Zenker GmbH Rank 86 of 108

The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Fixed Assets, increasing the Economic Capital Ratio by 30% points. The greatest weakness of Bien Zenker GmbH is the variable Net Income, reducing the Economic Capital Ratio by 41% points.

The company's Economic Capital Ratio, given in the ranking table, is 203%, being 51% points below the market average of 255%.
