

The relative strengths and weaknesses of MSB Bauausführungen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MSB Bauausführungen GmbH compared to the market average is the variable Due After More Than1 Year, increasing the Economic Capital Ratio by 211% points. The greatest weakness of MSB Bauausführungen GmbH is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 346% points.

The company's Economic Capital Ratio, given in the ranking table, is 211%, being 39% points below the market average of 250%.







